THE CONDITIONS OF THIS STUD SERVICE CONTRACT ARE AS FOLLOWS:

1. All fees are payment for the stud service only, and are not to be construed as a guarantee of puppies surviving the whelping. At least two (2) puppies whelped alive, pasted ten days constitutes a litter.
2. The stud service fee is payable in full at the time of the first breeding unless otherwise specified in this paragraph. (*) i.e. - In lieu of the stud fee, the owner of the stud dog shall select a choice/pick of the litter puppy. Stud Fee \$ _____ Pick Of The Litter _____ . If the choice/pick of the litter option is taken, Double "H" Birddogs will make a choice/pick no later than six (6) weeks of age. Double "H" Birddogs also has the sole right to name the choice/pick of litter puppy it takes possession of.
3. Double "H" Birddogs guarantees that the stud is potent, free of signs and symptoms of disease or congenital defects, and that a mating was achieved on at least one of the above mating dates.
4. If there is no whelp (pregnancy) from the mating described above, the bitch owner must give notice not later than thirty (30) days after mating. A return service will be provided, at no

additional charge, only at the next heat cycle (and only this heat) of the same bitch. The same stud dog, if available will provide the return service. If the stud dies, is sold, or otherwise not available, Double "H" Birddogs has the right to mate the bitch with another one of its studs. The choice of which stud to use is up to Double "H" Birddogs, unless both parties mutually agree on another choice.

5. The owner of the bitch certifies that the bitch has not been bred to any other male dog during this heat cycle, and that the utmost care will be taken to insure that she is not bred to any other male dog after this service has been provided. Also, that the puppies will be given proper care.
6. All transportation expenses are the responsibility of the owner of the bitch. By airfreight or ground prepaid to a designated location determined by Double "H" Birddogs.
7. There is no refund or cancellation of the fee if no whelp (pregnancy) occurs or there is no surviving puppy from either mating.
8. Any bitch that cannot be bred due to viciousness, fear, or any other extreme behavior problem will be immediately returned to the owner of said bitch and no payment will be due.
9. It is understood that Double "H" Birddogs shall maintain responsible care of the bitch while at our facility. It is also understood that the owner of the bitch will assume all costs incurred by Double "H" Birddogs for any medical treatment by a veterinarian required for the bitch while under our supervision.
10. It is the responsibility of the owner of the bitch to advise Double "H" Birddogs of any habits, behavioral problems and/or medical conditions of the bitch described above.
11. The owner of the bitch shall certify that the bitch is current on all immunizations, de-worming, free from any diseases and congenital defects and is negative for Brucellosis.
12. The owners of the bitch certifies that the bitch is at least two (2) years old.
13. Double "H" Birddogs will appraise the offspring of this breeding for the owner of the bitch at no charge when the puppies are six (6) weeks of age. Owner of the bitch will make an advanced appointment for this service.
14. If ownership of bitch changes during whelp or before puppies are 6 weeks old, Double "H" Birddogs is not required to sign litter registration papers.
15. No offspring from this mating are to be offered for sale, either directly or indirectly, to or through any pet shop, grooming parlor, humane organization, pet broker, mass production kennel (puppy mill), wholesaler, pet dealer or any other commercial distributors. The bitch owner also agrees to find a good home for each puppy and not to take any of them to the pound or Humane Society. If the bitch owners cannot find suitable homes for the puppies and is unable to care for them they may be taken (with AKC paperwork) to the Double "H" Birddogs facility for placement. If puppy(s) is/are taken to the Double "H" Birddogs facility the owner of the bitch forfeits any payment and forever will relinquish and quit any claim of responsibility and puppy ownership.
16. Double "H" Birddogs will, as a matter of courtesy only, refer prospective puppy buyers to the owner of the bitch when the puppies are at least six (6) weeks old.

- 17. Double "H" Birddogs is not required to sign the application for registration of a resulting litter until all fees are paid and all conditions of this contract are met.
- 18. There are no other terms or conditions unless stated herein.
